CONSIGNMENT, COMMISSIONS, AND PAYMENT

1. The Consignor releases Turnbull Equine Productions hereinafter referred to as TEP, Virginia Horse Center Sale Facility, Auctioneers, employees and representatives from any and all responsibilities, liabilities, law suits, or legal proceedings arising from the sale of this horse. If legal action is initiated against TEP involving the sale of this horse, the consignor agrees to fully indemnify TEP from such suit, including legal fees and costs.
2. **All consigned entries who pay a \$75 fee, are eligible to compete in the Trail Horse competition (\$2,000 added money). All consigned entries who pay a \$125 fee, are eligible to compete in the Ranch Horse Competition (\$1,000 added money).**
3. **All consignments must have a negative Coggins test within 12 mo. and a 30 day health certificate. Entries may be any breed, registered or not. Entries must be at least four (4) years old (as of Jan. 1. No stallions. No pregnant mares. NO SUBSTITUTIONS! The consignor agrees to pay sale management a consignment fee of \$175.00. The consignment fee is non-refundable after acceptance by sale management. The consignment fee must accompany the consignment contract. When applicable the transfer report must be signed by the owner or legal agent. In the case of multiple transfers, the consignor will be responsible for all fees necessary to complete the transfer to the owner of the horse at the time of consignment. The transfer fee to the buyer will be the only transfer fee paid by the buyer. Sellers of non-registered horses will be required to sign a bill of sale.**
4. Upon the sale of the horse to a bona fide buyer, the Consignor agrees to have deducted from any proceeds the commission of \$100 or 10% of the final bid whichever is greater. The commission is in addition to the consignment fee. **Once the horse is on the sale grounds, all sales transactions must be processed by the sale office.** All horses must go through the sale ring. NO EXCEPTIONS! If the final bid is not accepted by the Consignor, no commission is charged; however, a \$75 NO SALE FEE will be assessed. The consignor will be charged a commission for any horse consigned to the auction that was not sold at the auction, but sold to an active, registered buyer at the sale within 14 days following the auction. This transaction must be processed through the sales office to insure protection of the Consignor and the Buyer.
5. Proceeds from the sale will be paid and sent by regular mail to the appropriate recipient (see front of contract) no later than 10 banking days following the date of sale provided that any and all disputes have been resolved to the satisfaction of all parties. The Consignor agrees that if the payment of this horse is incomplete for any reason by the Buyer, Sale Management shall not be liable for the payment or the collection of the sale proceeds or the return or wellbeing of said horse. Sale management shall make every effort to assist in the collection of the sale proceeds, recovery, or re-sale of the horse. The Consignor understands that Sale management does not guarantee the validity, payment or collection of any instrument received in payment of the sale proceeds of any horse.

REPRESENTATION POLICIES and SOUNDNESS GUARANTEE:

6. The Consignor shall declare any and all unsoundness, vices, physical defects and/or cosmetic alterations, and that the horse is suitable to the purpose it is represented, prior to the sale of the horse, understanding that these statements will be announced. This shall include, but not be limited to, defects with **eyes, mouth, breathing, CRIBBING, weaving, nerving, ridgeling, founder, overbite, navicular disease, ringbone, or cryptorchid, or any artificial enhancements such as tail extensions or other enhancements. A lame horse or a horse sold with one or more of these conditions that was NOT announced at the time of sale CAN be rejected by the Buyer within five (5) days of the date of sale and returned to the Consignor at the Consignors expense. This rejection must be accompanied by a certificate from a qualified equine veterinarian and agreed upon by sale management, the Consignor and the Buyer. If the horse is rejected for any unsoundness or other misrepresentation, the consignor forfeits all entry fees and commission will not be refunded to the Consignor. There is no guarantee between consignor and buyer of compatibility or disposition. A horse that colics, has a fever, cold or flu, will not be considered unsound. A horse that dies within the 5 day soundness guarantee, shall remain the property of the buyer.**
7. HYPP Testing: Sale management recommends that horses that are the lineal descendant of the AQHA stallion IMPRESSIVE be tested for HYPP (Hyper-Kalemic Periodic Paralysis). The results of this test will be printed in the catalog and announced at time of sale.
8. Permission is hereby granted to the Sales Management to edit or add to the Owner's Statement furnished on this contract.

OWNERSHIP AND TRANSFER:

9. Consignor warrants clear title to the horse with transfer of ownership in order. Sale management must be informed of any and all liens at time of consignment. The Consignor retains ownership until the gavel falls. The Consignor is responsible for any feed, care, and presentation of the horse. Should a Buyer default on the purchase or reject this horse after it is sold, the Consignor agrees to allow this horse to be auctioned a second time at the first available opportunity during the sale. Sale management, sales facility, or anyone else directly or indirectly involved with this sale assumes no liability for the horse whatsoever.
10. Consignor has the right to turn down the final bid as a NO SALE. The auctioneer must be informed immediately of the NO SALE. If the Consignor allows the Buyer to sign the sales ticket, the horse is considered sold. NO EXCEPTIONS!
11. Horses will sell in catalog order. Sale management has the authority to assign stalls, reject any horse, and make any announcements or additions to enhance the sale.
12. The Consignor releases TEP, the Virginia Horse Center and all its employees, representatives, and spectators from any responsibility for any accidents that may occur to horses or equipment, or for loss by fire, theft, injury or death to any human or animal in any way or manner.
